## **PERMA PANEL WARRANTY**

INLAND PLYWOOD COMPANY hereby provides the following limited warranty to the original purchaser of this product from the invoice date of said purchase.

1. A lifetime warranty from manufacturing defects when the damage or defect would make the product structurally unfit for its intended purpose.
2. A lifetime warranty against damage as a result of fungal decay / rot.
3. A lifetime warranty against damage by termites.

Within ninety (90) days of receipt of a properly filed claim, together with all documentation, including but not limited to the original purchase invoice prepared by INLAND PLYWOOD COMPANY to said original purchaser showing the date of purchase, serial number of end product, name of manufacturer, and name of the Original Owner, INLAND PLYWOOD COMPANY shall arrange for proper exchange of damaged plywood by the Manufacturer / Original Owner. Upon receipt of such replacement plywood, INLAND PLYWOOD COMPANY agrees to pay the costs arising from the replacement defective products for a period of ten (10) years. After a ten-year period, INLAND PLYWOOD COMPANY will only agree to exchange the damaged panels.

In the event the Original Owner sells the subject boat, this warranty shall be transferred to the Second Owner for a period of ten (10) years from the date of purchase by the Original Owner.

To properly file a claim, forward all information concerning the claim to INLAND PLYWOOD COMPANY, 256 Olive St., Cocoa, FL, 32922, within the Warranty period.

This Warranty is limited to the above items and is the purchasers exclusive remedy. INLAND PLYWOOD COMPANY shall not be responsible for, and this Warranty does not cover any of the following:

1. Damage caused from anything other than fungal decay/rot, termites and/or other wood eating insects or panel workmanship.
2. Associated damages claimed to be a result of damage caused by fungal decay/rot, termites and/or other wood eating insects or panel workmanship.
3. Damage to panels caused by swelling, shrinkage, and/or discoloration.
4. Inherent wood characteristics such as checking, leafing, splitting and broken grain.
5. Damage as a result of improper installation, or the use of corrosive fasteners.

INLAND PLYWOOD COMPANY'S OBLIGATION UNDER THIS WARRANTY AND ITS LIABILITY IN CONTRACT, TORT, WARRANTY NEGOTIATIONS OR OTHERWISE IS LIMITED TO THE REPLACEMENT OF THE DAMAGED PRODUCT AND THE COSTS RESULTING FROM REPLACING THE DEFECTIVE PRODUCTS. UNDER NO CIRCUMSTANCES SHALL THE SELLER BE LIABLE FOR SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES. THE INVOICE PRICE IS CONSIDERATION FOR THIS LIMITATION.
